## Encounter Data Front End System (EDFES) – Pre-Screen Validation Report

#### **Report Description**

The EDFES Pre-Screen Validation Report is conditionally generated when an encounter submitter transmits X12 files to EDFES. These pre-screening edits are performed prior to TA-1 level editing in the translator.


The purpose of the report is to provide results from the execution of certain edits on the transmitted file. The edits are the result of errors related to Submitter ID, Receiver ID, Claim Type, file size, missing segments, or invalid X12 Version 5010 data.

- If the Pre-Screen is successful, no report is produced and the file proceeds to the Interchange Envelope Validation.
- If the Pre-Screen fails for one or more edits, the file is rejected, and an invalid report is sent to the submitter. The file does not proceed to the Interchange Envelope Validation. The submitter must correct and resubmit.

This report is best viewed with a text editor.
