Risk Adjustment Processing System (RAPS) – Monthly Plan Activity Report

Report Description

The RAPS Monthly Plan Activity Report provides a summary status of the submissions by submitter ID and contract number.

- Provides a summary of the status of submissions for a one month period
- Arrayed by provider type and month ordered by THROUGH date of service
- Reported by submitter ID and H number
- Allows month-by-month tracking for all diagnosis clusters submitted

Using this report, MAOs and other entities can determine the number of clusters sent and processed during the month, and the status of that data (accepted, rejected, stored, model stored, and accepted and rejected deletes) by source. Report will display twelve months of the year but it is generated only when a plan has activity within the month.


This report is best viewed with a text editor.

8	Submitter ID	The submitter identification number for the plan. A submitter may submit for more than one organization (H-number).
9	Provider Type Name	The provider type name for the RAPS Monthly Plan Activity report counts.
10	Monthly Submission Counts by Month	The diagnoses submission counts by Provider Type by Month for a one-month period.
11	Total Submitted	The summary total number of diagnosis code submission counts by Provider Type in a month.
12	Total Rejected	The summary total number of diagnosis codes rejected by Provider Type in a month.

15	Total Model Stored	The summary total number of required diagnosis codes that were stored by Provider Type, and are included in the model in a month.
16	Total Dele Acpt	The total number of deletes submitted for the file that were accepted in the database.
17	Total Dele Rjct	The total number of deletes submitted, but rejected, for the file.
