TA1 – Interchange Acknowledgement Report

Report Description

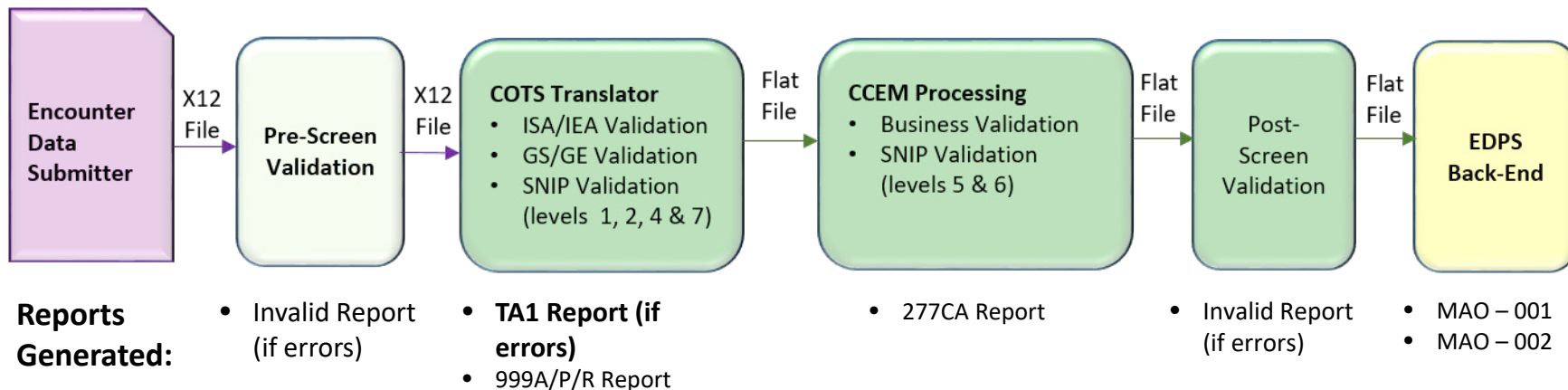
The TA1 Interchange Acknowledgement Report provides syntax editing for Interchange envelope conformance (ISA/IEA level). If an error is found, the entire file is rejected and the EDFES generates and returns the TA1 Interchange Acknowledgement report within 24 hours of the submission.

Note the following details regarding Interchange edits and the TA1 report:

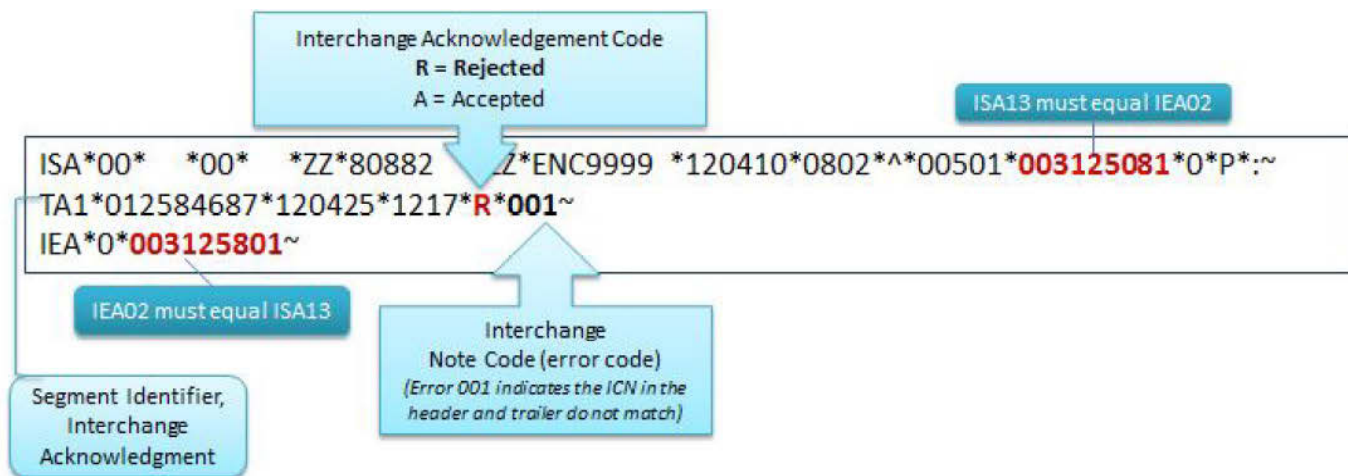
- The submitter will only receive a TA1 report if there are syntax errors in the file, causing the file to be rejected.
- The TA1 is a single segment and is unique in that it is transmitted without the GS/GE envelope structure.
- The notice of the file rejection and the specific error is within the TA1 segment.
- The TA1 report includes the Interchange Control Number, Interchange Date and Time, Interchange Acknowledgement Code, and Interchange Note Code.

This report is best viewed with a text editor.
