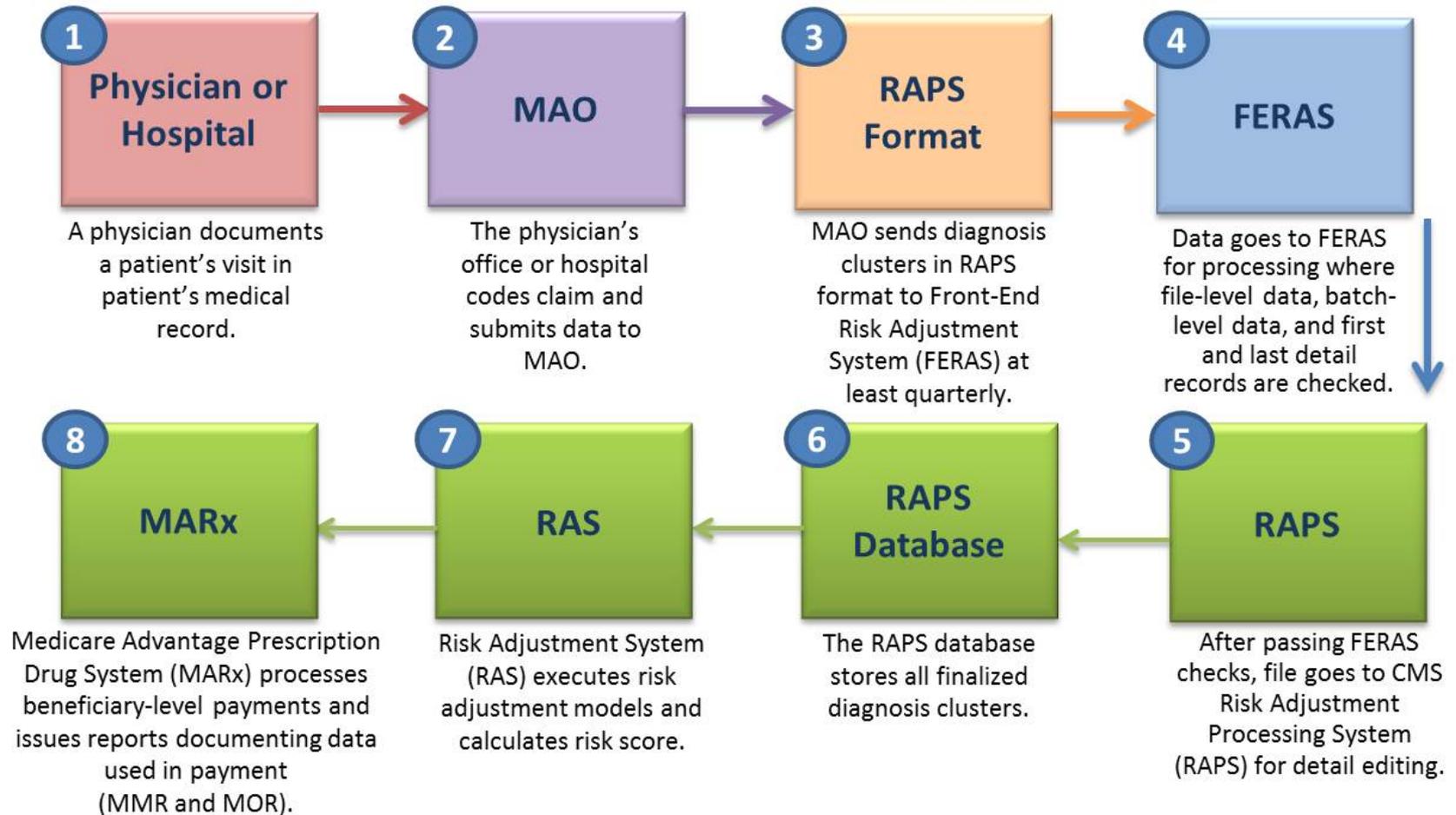
RAPS Overview

Risk Adjustment

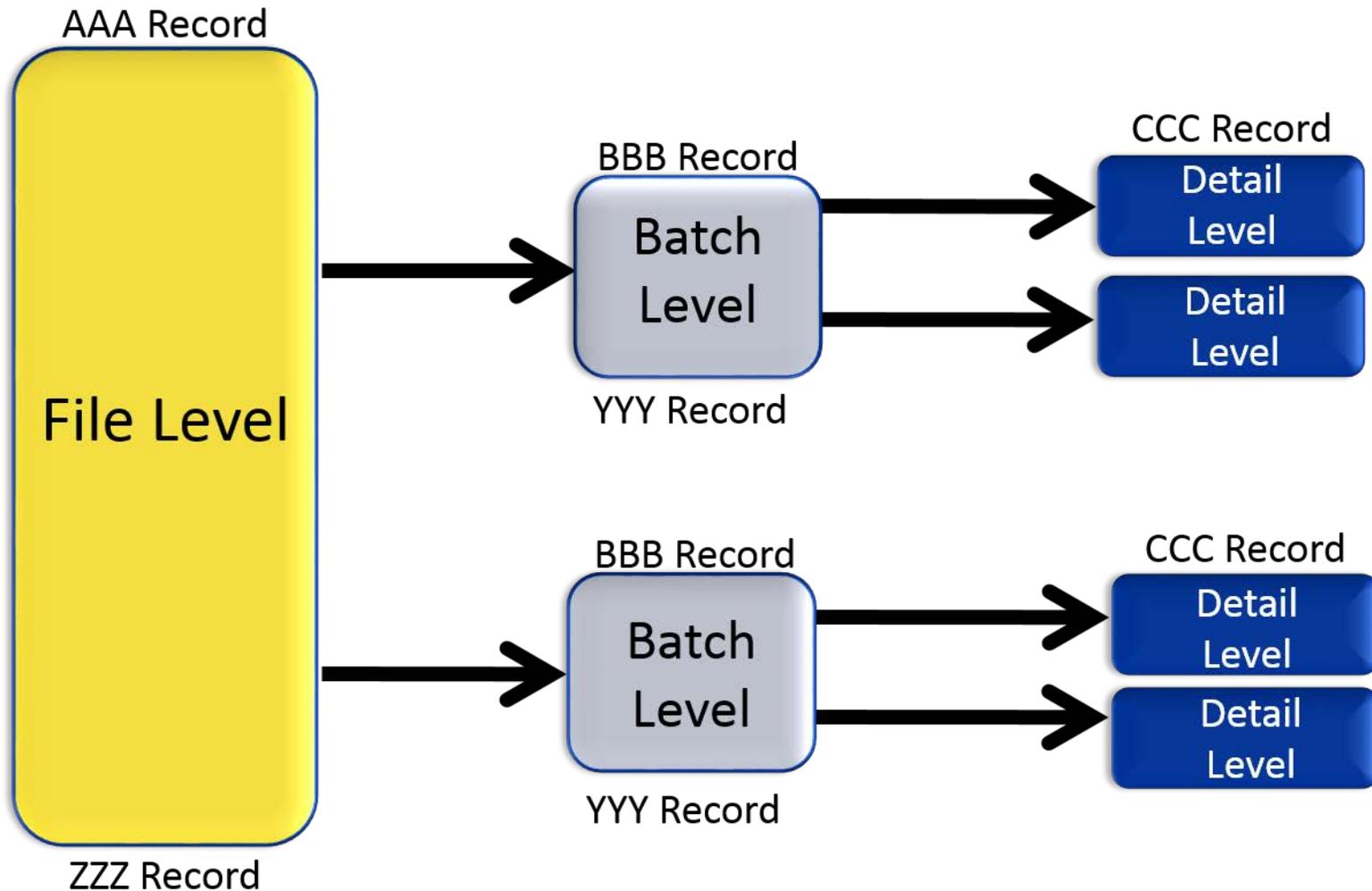
Risk Adjustment:

- Used to adjust plan bids and to adjust all MA and Part D payments
- Medicare risk adjustment is prospective, meaning diagnoses from the previous year, along with demographic information, are used to predict the relative cost of each beneficiary in the payment year

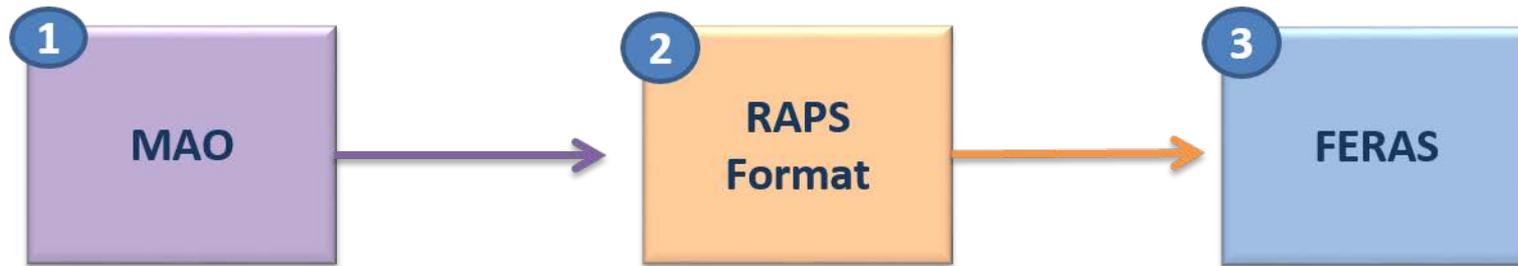

Required Minimum Data Elements for RAPS Submission

- Health Insurance Claim Number (HICN)
- Acceptable Provider Type
- “From” Date of Service (DOS)
- “Through” Date of Service
- Diagnosis Code (ICD-10)
 - ICD-10- starting with DOS of 10/1/15

The physician's office or hospital codes claim and submits data to MAO.

RAPS Format

MAO sends diagnosis clusters in RAPS format to Front-End Risk Adjustment System (FERAS) at least quarterly.

3
FERAS

Data goes to FERAS for processing where file-level data, batch-level data, and first and last detail records are checked.

Correcting Rejected Data

- Rejected data are reflected in cumulative totals for the appropriate month and number of total rejections
- When a cluster is counted as stored, it remains part of the stored count on the Cumulative Plan Activity Report, even if it is deleted
- Deleted clusters are included in total stored and total deleted
- Reports can help identify internal processes affecting data collection and submission, as well as external issues affecting data collection

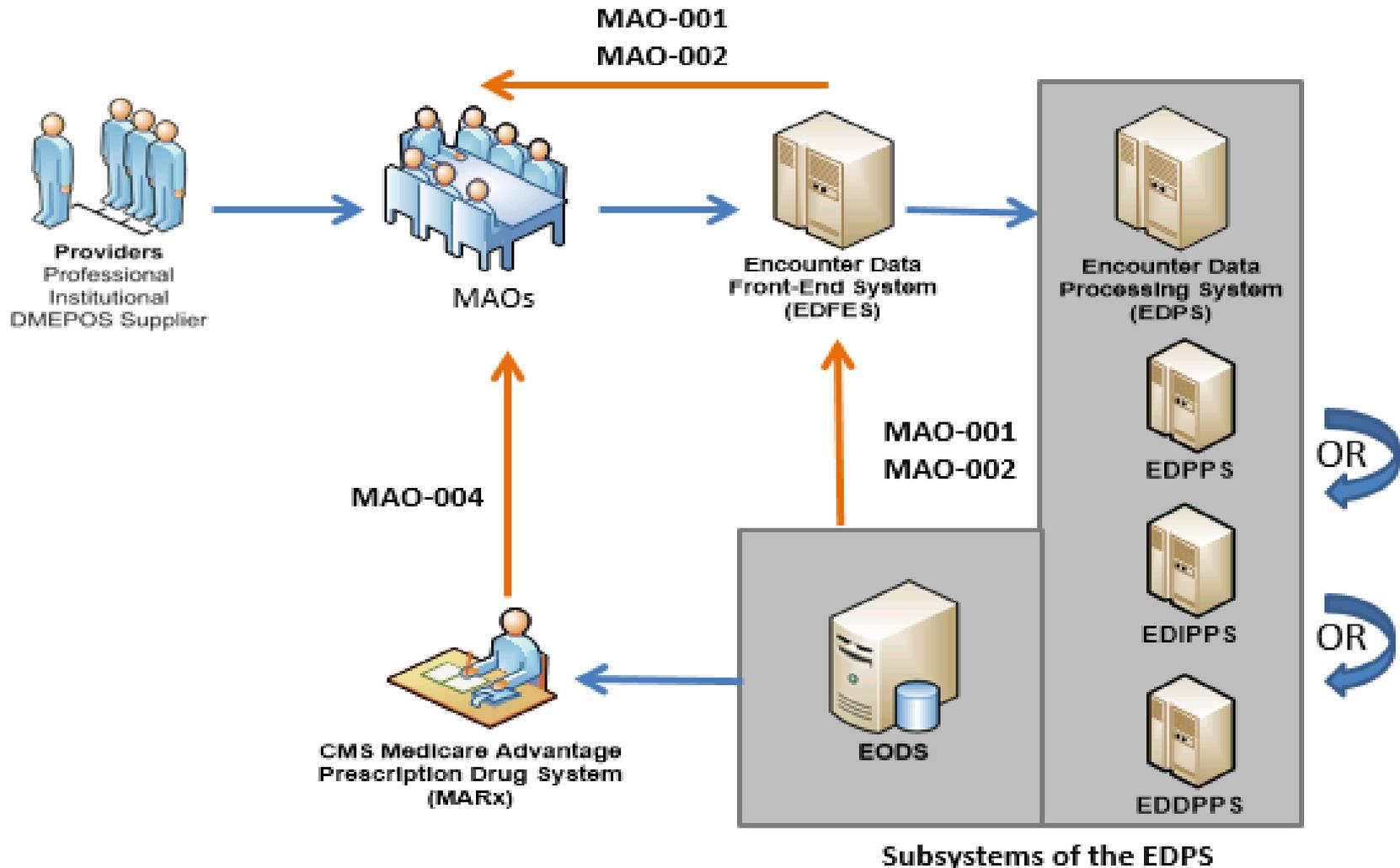

- Plans should correct errors and resubmit as soon as possible.



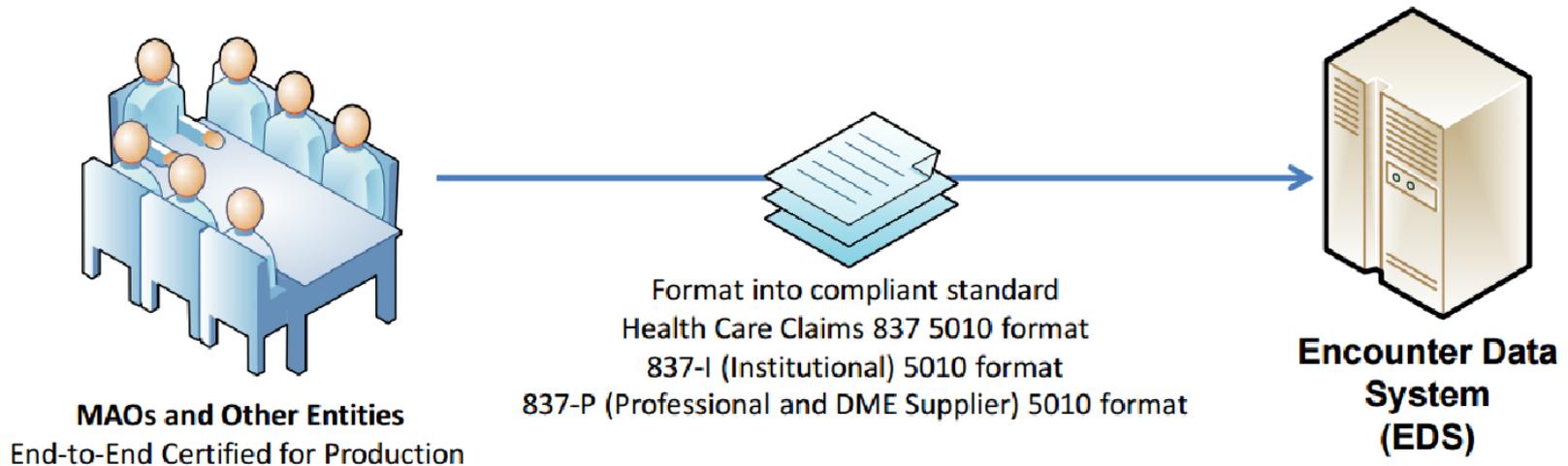

837 5010 Format Requirements

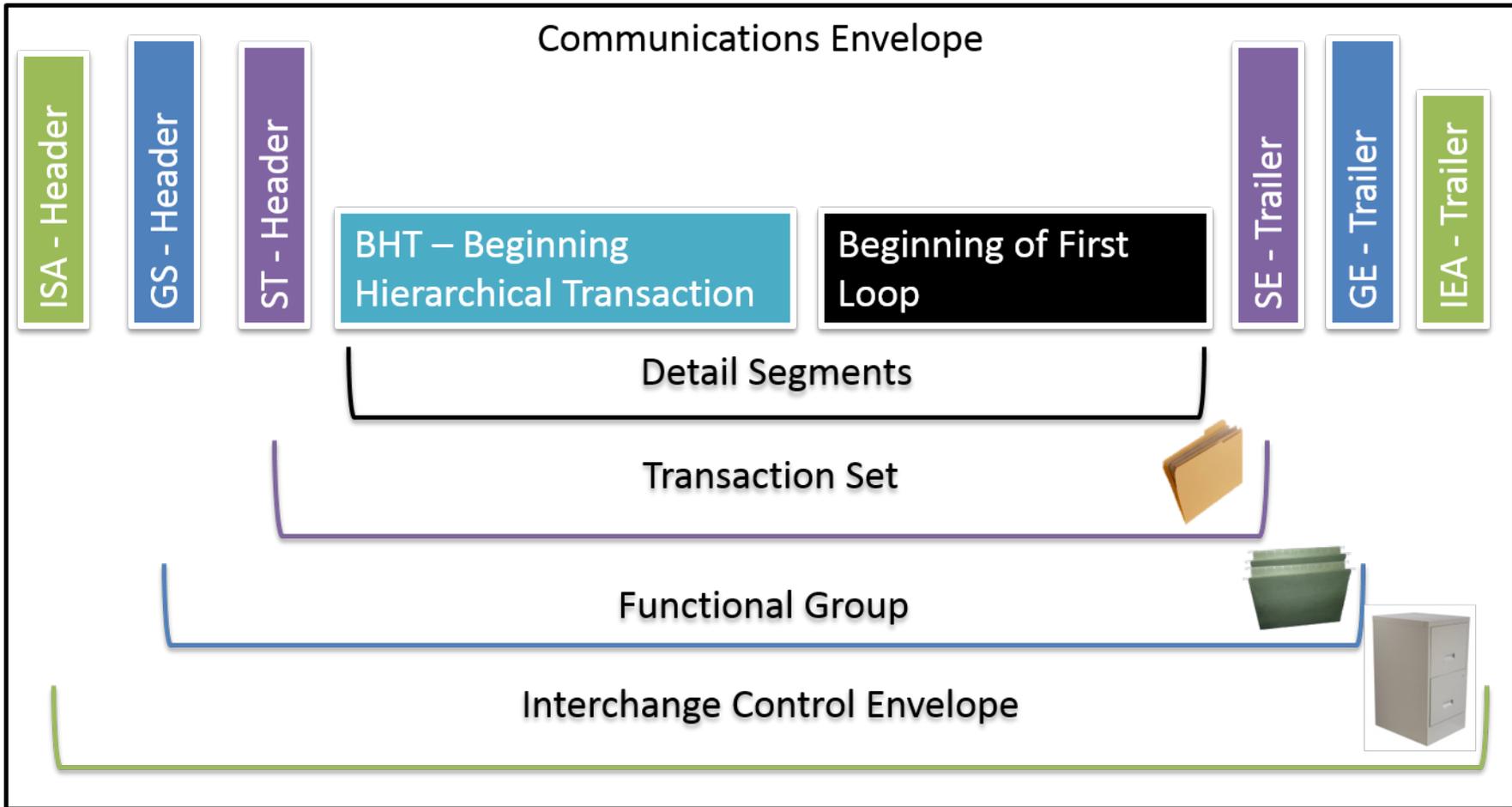
- Encounter Data:
 - must be submitted in the ANSI X12 837 5010 format
 - must contain minimum data elements
 - must also adhere to the TR3 transmission structure



Submission Format

- The 5010 837 submission format is comprised of:
 - Interchange Control Group (ISA/IEA)
 - Functional Group (GS/GE)
 - Transaction Set (ST/SE)
 - Detail Segment (BHT)
 - Loop, segments, and data elements
- The Interchange Acknowledgement, Functional Acknowledgement, and Proprietary Error Reports address errors contained within the ANSI X12 5010 837 submission

EDS Transmission Envelope Structure

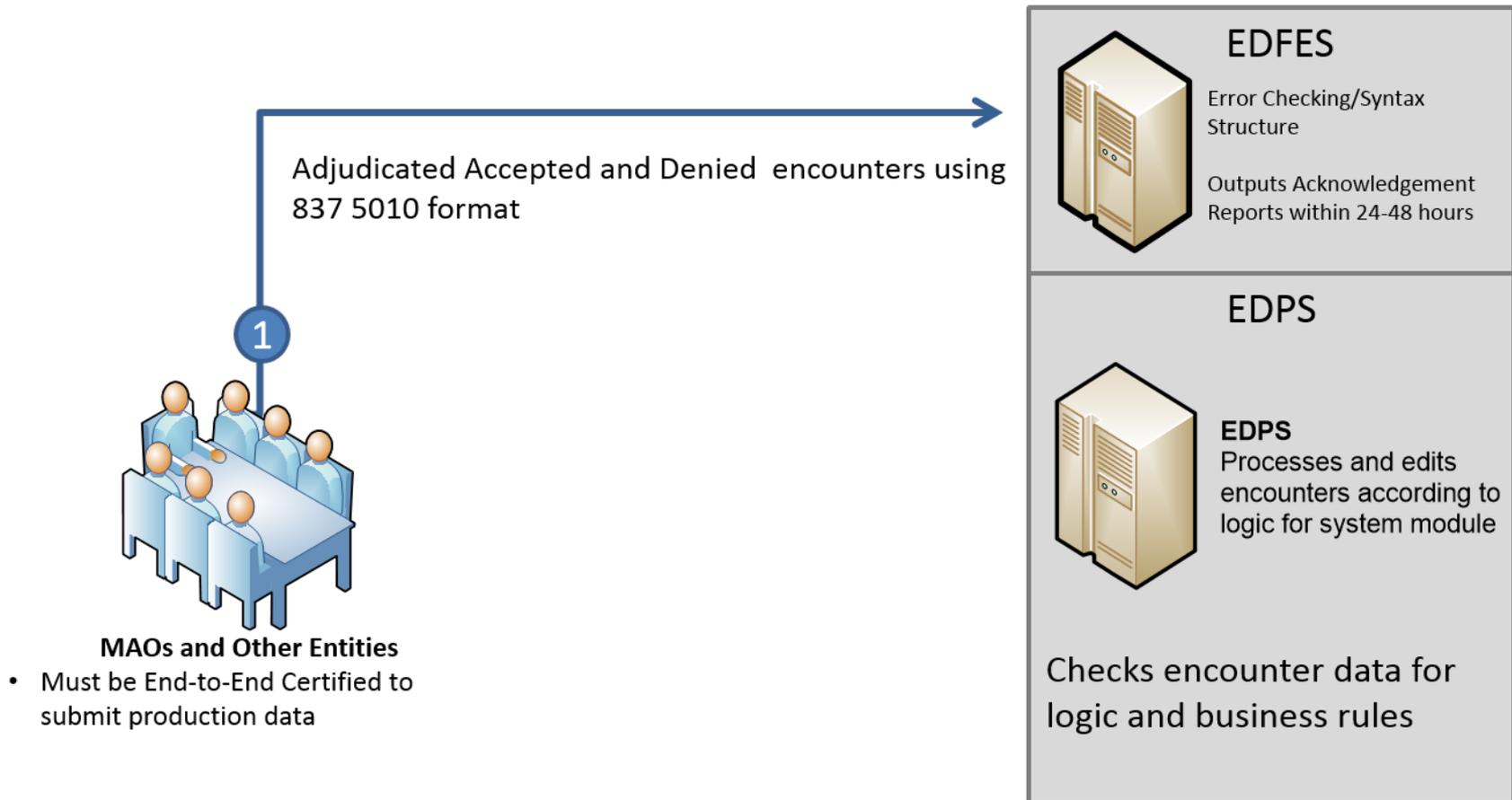

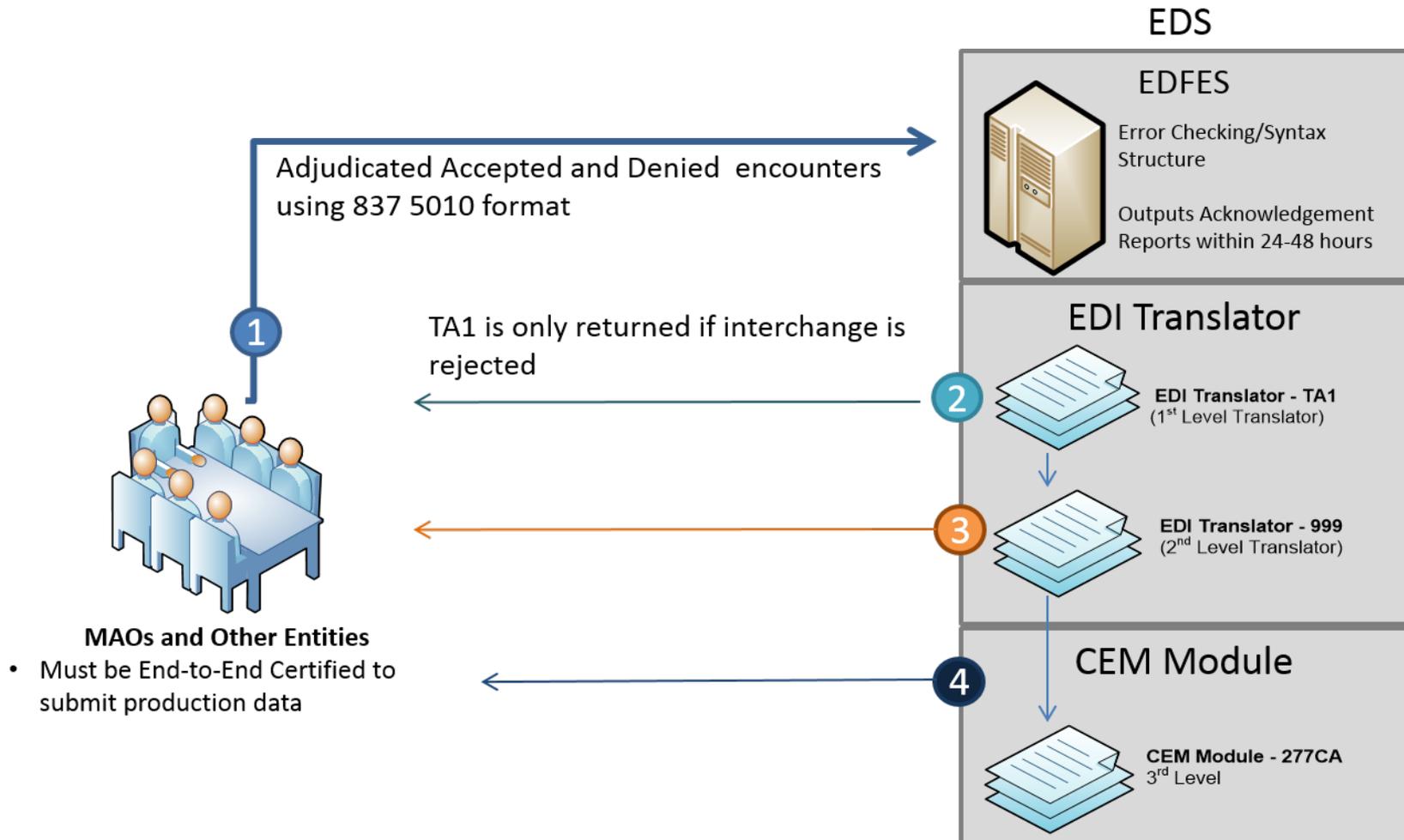
- MAOs are required to submit encounter data on a frequency based on the contract's enrollment size

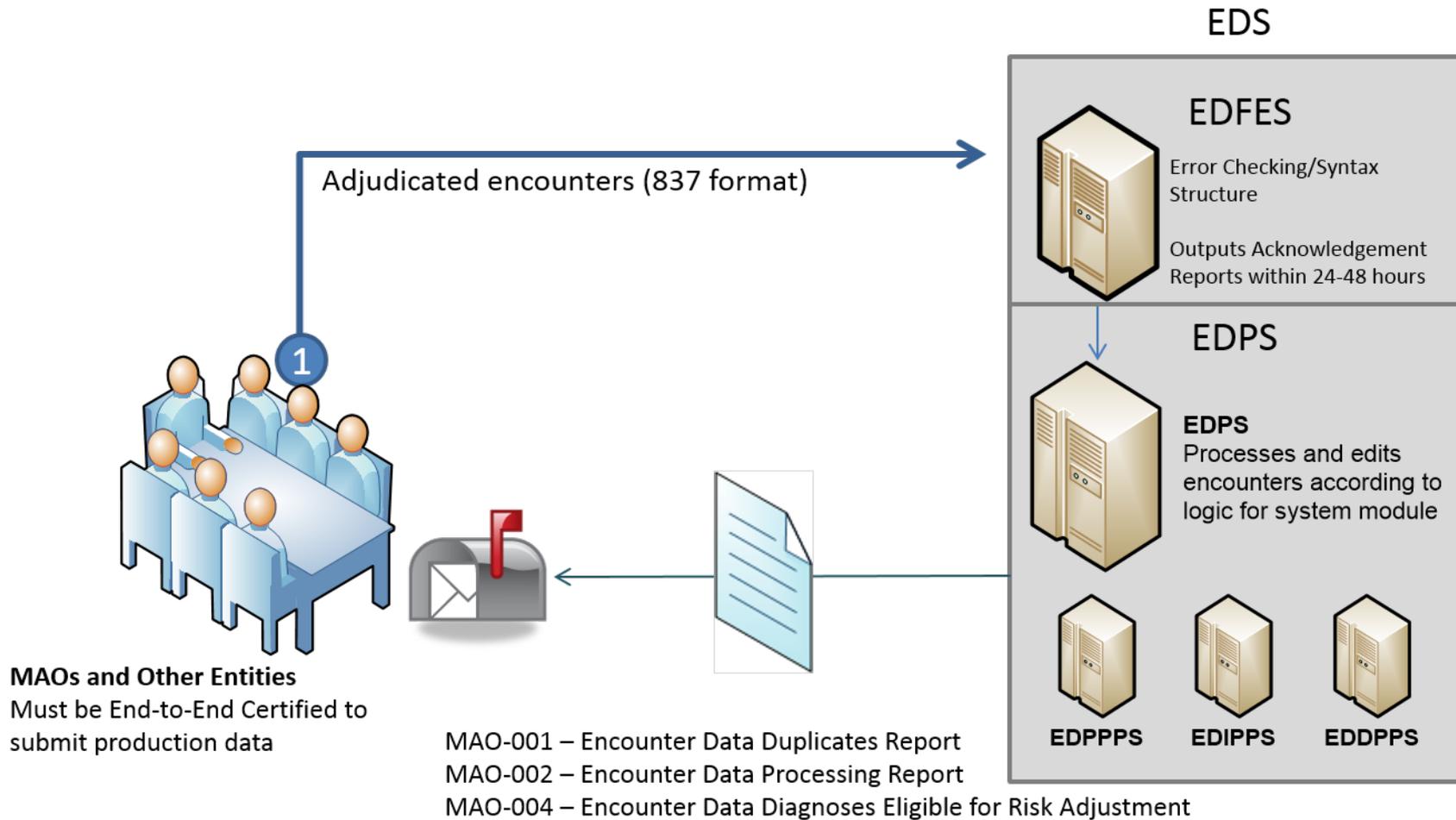

999	Provides notification implementation compliance status
277CA	Provides a claim level acknowledgement of all encounters received

EDPS Processing Status Reports

EDPS Report Type	Description
MAO-001 Encounter Data Duplicates	Lists all encounters that received duplicate errors (98300, 98325, 98320, and 98315) *MAOs and other entities will not receive the MAO-001 report if there are no duplicate errors received on submitted encounters
MAO-002 Encounter Data Processing Status	Lists the accepted and rejected status of all encounters for claim and line levels along with error codes
MAO-004 Encounter Data Diagnoses Eligible for Risk Adjustment	Phase III MAO-004 reports will list all diagnoses from accepted professional, inpatient, and outpatient encounter records, and indicate which diagnoses are considered for risk adjustment



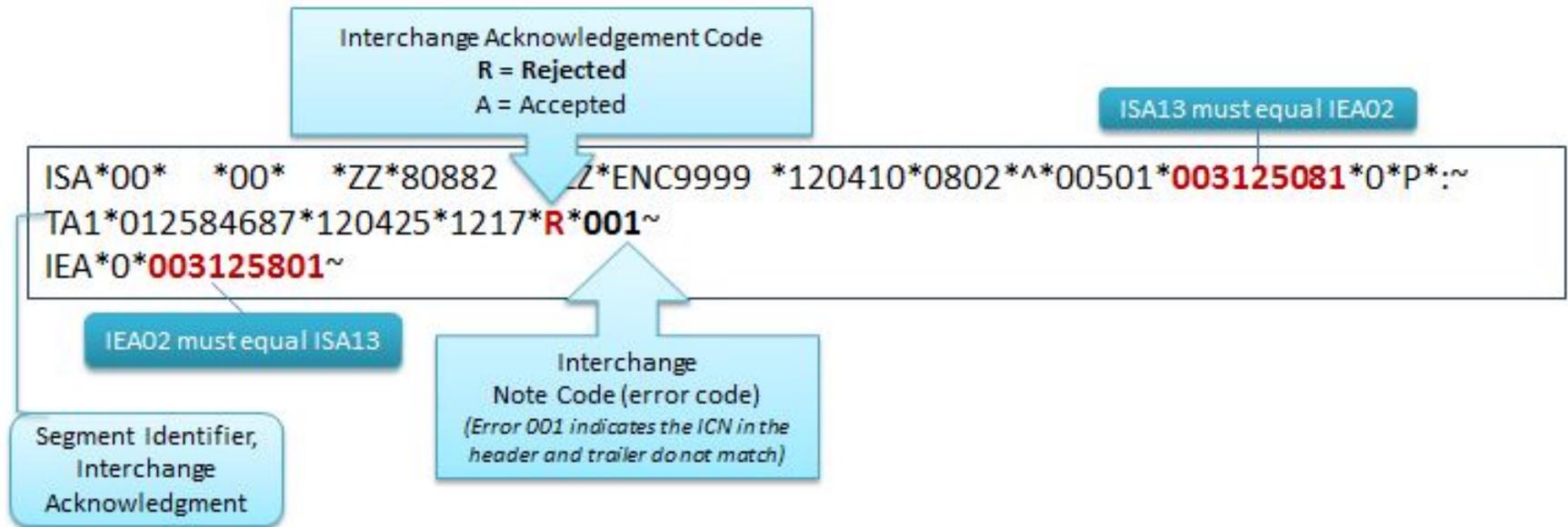
EDFES Acknowledgement Reports

TA1 Acknowledgement Report

- Upon receipt of the inbound 837, the EDI Translator performs syntax editing
- Issues detected in the ISA/IEA interchange will cause the 837 file to reject
 - MAOs must correct and resubmit the entire file
- A TA1 Acknowledgement report is generated if the transaction is rejected

TA1 Acknowledgement Report (continued)

- TA1 Acknowledgement Report with inconsistent Interchange Control Numbers (ICNs):



For EDS processing, a TA1 is generated only when there is a rejection

999 Acknowledgement Report

- The 999 Acknowledgement Report is generated following Common Edits and Enhancements Module (CEM) edits to verify the syntactical accuracy of data
 - Identifies the processing status of functional groups (GS/GE) and transactions sets (ST/SE)
 - 999A = all transaction sets were accepted
 - 999P = partially accepted (at least one transaction set was rejected)
 - 999R = syntax errors were noted and submitter needs to correct/resubmit

999A Report Example

- If an “A” is displayed in the IK5 and AK9 segments, the claim file is accepted and will continue processing.

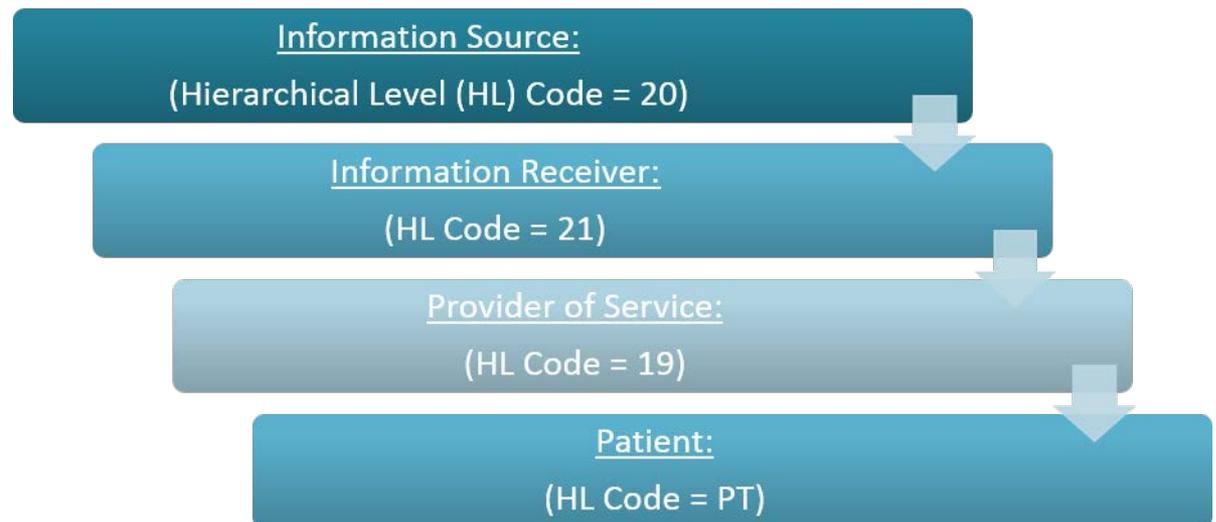

277CA Acknowledgement Report

- Returned to submitter for accepted encounter files or rejected encounter segments
 - Rejection responses based on edit failures detected by CEM
- Assigns an ICN for each ***accepted*** encounter

Note: Rejected encounters must be corrected and resubmitted in order to receive an ICN

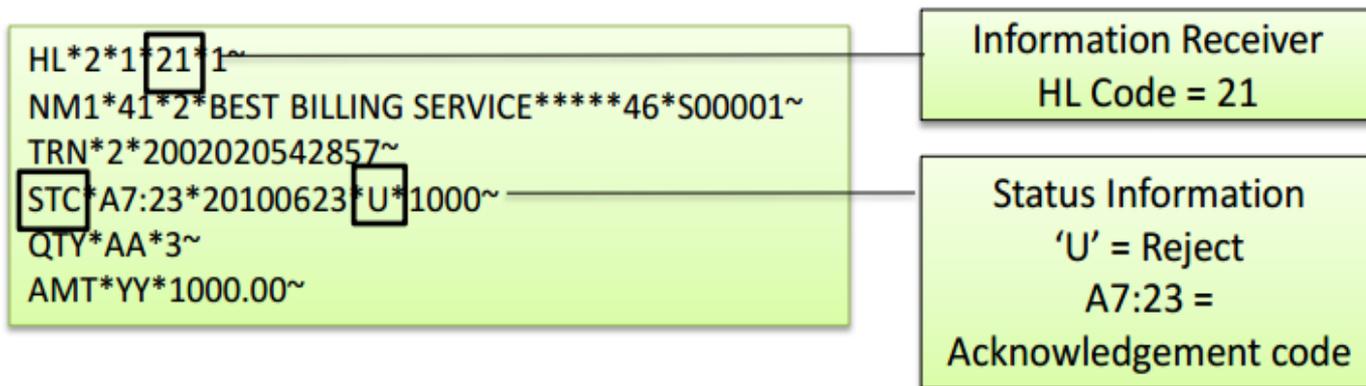

 - STC01 data element will list the Acknowledgement Code, Claim Status Category Code and the Claim Status Code
- “WQ” = HL accepted



EDPS Processing Reports

Report Layout

- MAO reports are delivered to submitters in a fixed length format and distributed by two methods:
 - Flat file
 - Formatted
- Flat file reports are categorized by:
 - Header record
 - Detail record
 - Trailer record
