

## Appendix 3C: Medicare Beneficiary Identifier (MBI) Edits for Encounter Data and RAPS Data

The Medicare Access and CHIP Reauthorization Act (MACRA) of 2015 requires that CMS remove Social Security Numbers (SSNs) from all Medicare cards by April 2019. A new Medicare Beneficiary Identifier (MBI) will replace the SSN-based Health Insurance Claim Number (HICN) on new Medicare cards. CMS will begin issuing new Medicare cards with the new MBIs to Medicare beneficiaries on April 1, 2018 and continue through April 2019.

A number of edits will be implemented in the Encounter Data System and the Risk Adjustment Suite of Systems to ensure that MBIs can successfully be submitted. Details are provided in the tables below.

As stated in this memo, the following edits will go into effect beginning April 1, 2018.

| Edit Code | Edit Description   | Notes   |

| 503       | BENEFICIARY IDENTIFIER HAS CHANGED ACCORDING TO CMS RECORDS; USE CORRECT IDENTIFIER FOR FUTURE SUBMISSIONS | RAPS Daily process produces informational Error Code of “503” if the MAO submits a HICN, RRB, or MBI that is not the current CMS beneficiary ID. Specifically, if the MBI is submitted, but the beneficiary’s MBI has been updated, the new MBI will be sent back. If the HICN was submitted, but the HICN has been updated, the updated HICN will be sent back. In the Beneficiary Identifier Error field, the current Beneficiary Identifier will be returned in the outbound CCC transaction record. This condition does not stop the additional editing/validation on the other fields. |
